



TSA DISCIPLINE, PROTEST AND APPEALS FEES
Schedule of Fees, Fines, Bonds and Penalties

1	Each <i>Governing Organization</i> shall define the amounts for its own "Schedule of Fees, Fines, Bonds and Penalties" to be implemented in discipline cases under its jurisdiction and shall include such schedule in its "Published Rules".
2	The "Schedule of Fees and Penalties" outlined in the following table is applicable only to cases handled by an O.S.A. <i>Discipline Hearing/Review Panel</i> and are mandatory amounts.
3	Discipline Hearing Administrative Fees:
3.1	A "Discipline Hearing Administrative Fee" may only :
	a) Be charged if the accused registrant is found guilty
	b) In the case of a player, <i>coach</i> or <i>administrator</i> , be charged to the Club with which the guilty person is registered or affiliated
3.2	Discipline by Review (DBR) Fees: A DBR Administration fee may only be charged if found guilty.
4	Of the \$250.00 "Discipline Hearing Administrative Fee" levied to the club of the accused when the accused has been found guilty of a game official assault , the District Association appointing the O.S.A. <i>Discipline Hearing Panel</i> shall retain \$200.00 and remit \$50.00 to the O.S.A.
5	Bonds
5.1	A Bond may be levied at the discretion of a <i>Governing Organization</i> for a specified period of time and purpose. There will be no interest paid to the person or organization required to submit the bond and this shall be so stated.
6	Failure to pay monetary fines, administrative fees or bonds within the required timeframes stipulated in the written decision:
6.1	Any registrant failing to pay a fine, fee, or bond imposed by a <i>Discipline Hearing/Review Panel</i> shall be subject to an additional monetary penalty and, if still unpaid, shall be subject to suspension and shall remain under suspension until any imposed penalty (plus the original fee fine or bond) is paid. Full payment of all discipline fines and fees is due within 30 days of date of notification of decision.

Penalty for failure of Club to Pay Discipline Hearing Administrative Fee in a case in which one of its players, <i>coaches</i> , or <i>administrators</i> , or the Club itself (for a case involving its spectators and/or unidentified players, <i>coaches</i> or <i>administrators</i>) has been found guilty of Game Official Assault	4.21	Club (if it fails to pay \$250.00 administrative fee within 30 days of the hearing)	250
	4.22	Club (if it fails to pay \$250.00 administrative fee and \$100.00 penalty within 60 days of the hearing)	250
	4.23	NOTE: A Club which is levied with Penalty #4.21 and #4.22 shall be suspended from all soccer activities until it pays \$250.00 administrative fee and both \$200.00 penalties.	
Penalty for failing to provide (by the required deadline) the required information about the charge involving Game Official Assault to the O.S.A. Office	4.31	District Association: for not submitting the required information (about the charges) within 10 days after charges are laid	100
	4.32	District Association: for not submitting the required information (about the decision) within 10 days after the decision is made	100
	4.33	District Association: for not submitting the required information (ie., Minutes, Findings, and Decision) within 30 days after the hearing is concluded	100
	4.34	District Association: for not submitting the required information (about the payment of fees, fines, bonds, and/or penalties) within 30 days after payment of such	100
Penalty for failing to provide (by the required deadline) the required information about the disposition of:	4.41	District Association, Provincial/Regional League : for not reporting, in writing within 30 days , the disposition of a caution report from an Ontario Cup game (in which the player is disciplined for accumulating three cautions)	100
	4.43	District Association, Provincial/Regional League : for not reporting, in writing within 30 days , the disposition of a dismissal report from an Ontario Cup game	
a) a caution report from an Ontario Cup game (in which the player is disciplined for accumulating three cautions); or b) a dismissal report from and Ontario Cup game			
Game Official No-Show	4.44	If failing to appear at a match the official was appointed to, he/she will reimburse the Club/District for the cost of the playing field and disciplinary action will be taken.
